- He/She has never had any criminal charges against him/her, nor does he/she have a criminal record.
- He/She has never behaved in such a way as to indicate that he/she might deal with minors in an inappropriate manner.
- He/She has not behaved in such a way as to indicate that he /she might be suffering from alcoholism or other forms of substance abuse.
- He/She has no mental, moral, or emotional condition which might adversely affect his/her performance as a religious.
- He/She is a legal permanent resident or possesses an appropriate current visa.
- He/She has completed Safe Environment Protocol training (including a criminal background check).

**The person representing your organization must have a completed a background check and Safe Environment Training within the last 5 years before they are allowed to present in our Diocese.**
